

**AN ORDINANCE TO AMEND ORDINANCE 2001-12 PROVIDING  
ALCOHOLIC BEVERAGE REGULATIONS**

**WHEREAS**, it is the intent and desire of the City Council for the City of Springville, Alabama (the "City") to promote and protect the public welfare; and

**WHEREAS**, the City desires to amend its Ordinance providing Alcohol Beverage Regulations – Ordinance 2001 -12 (referred to herein as the "Ordinance") to better protect and serve the general public and the citizens of the City.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Springville, Alabama, while in regular session, on the 3rd day of October, 2011, as follows:

**Section 1:** That Section VII, subsection (A), "Investigation," of the Ordinance is hereby amended to state as follows:

- A. The police chief or his designated officer shall conduct a background investigation of all applicants for a license. Said investigation shall include:
- (1) The following indices checks:
    - (a) Springville Police Department
    - (b) St. Clair County Sheriff's Office
  - (2) All other aspects of the application that the police chief deems useful in assisting the city council to render a decision.

**Section 2:** That Section VIII, "Producing Persons for Oral Interrogation," is hereby amended to state as follows:

Applicants by filing an application agree to produce for oral interrogation any person(s) requested by the City Council, when deemed necessary, to ascertain facts relative to the license application.

At a minimum, the applicant, or in the case of a partnership, association, or unincorporated enterprise, and/or officer thereof, shall be required to attend the council meeting at which the application is considered, and notice of such council meeting shall be provided to the applicant by the city clerk.

**Section 3:** That all ordinances or parts of ordinances in conflict herewith are, to the extent of such conflict, hereby repealed.

**Section 4:** That this ordinance shall become effective as provided by law after passage, approval and publication.
