Mayor William Isley called the regular meeting to order. Mike Ennis gave the invocation and David Jones led the Pledge of Allegiance.

Amendments to Agenda

David Jones made a motion to amend the agenda to consider installation of grass and irrigation at the Springville Station safe room. Katrina Hennings seconded the motion. All voted aye.

David Jones made a motion to amend the agenda to consider removal of a tree in the area of US 11 and Cross Street at a cost of up to \$2,000.00. David Vinson seconded the motion. All voted aye.

Minutes of June 3 Work Session and Regular Meeting

David Jones made a motion to approve the minutes of the June 3 work session and regular meeting. Sherry Reaves seconded the motion. All voted aye.

Resolution 2019-06 Weed Abatement 309 McGinnis Street

Sherry Reaves made a motion to adopt Resolution 2019-06 declaring a public nuisance of weeds and vegetation at 309 McGinnis Street and ordering the abatement of the nuisance. Herbert Toles seconded the motion. All voted aye.

Out-of-City Event Banners

The council discussed the zoning ordinance restrictions on banners for out-of-city events. Mayor William Isley asked James Hill provide guidance to the Planning & Zoning Commission regarding the definition of “community” as applied to the ordinance and to consider restriction of the time allowed for display of banners.

CDG Engineering Proposal-Archer’s Cove at Wright Farm

David Vinson made a motion to approve a proposal from CDG Engineers & Associates Inc in the amount of \$68,000.00 related to the residential development of Archer’s Cove at Wright Farm and expressly subject to the delivery of said funds to the City by the developer pursuant to that certain agreement entered into before between the developer, the City and the Odenville Utility Board. Sherry Reaves seconded the motion. All voted aye.

Board Appointments

Katrina Hennings made a motion to reappoint Candice Hill and Lisa Rayburn to five year terms on the Parks and Recreation Board. Sherry Reaves seconded the motion. All voted aye.

Tree Removal

David Vinson made a motion to approve the expenditure up to \$2,000.00 for removal of a tree in the area of US 11 and Cross Street. Herbert Toles seconded the motion. All voted aye.

Saferoom Grass and Irrigation

David Jones made a motion to approve installation of grass and irrigation at the Springville Station Saferoom at a cost of up to \$8,000.00. Herbert Toles seconded the motion. All voted aye.

Springfest Civil Air Patrol

Sherry Reaves made a motion to pay \$300.00 to the Civil Air Patrol for parking assistance during Springfest. Tim Walker seconded the motion. All voted aye.

Mayor's Report

The council discussed Movies in the Park, overhanging limbs preventing debris removal, pothole repair, trees on US 11 around the crosswalk signage and work on the lower pond at Big Springs Park.
