**Public Hearing – Rezoning of Jones Property**

David Jones made a motion to open a public hearing to receive comments regarding rezoning of property located on Highway 11 owned by Walter and Sharon Jones. Chip Martin seconded the motion. All voted aye. No public comments were heard. Jennifer Disker said that the Planning Commission has recommended rezoning the property from R-1 Single Family Residential to A-1 Agricultural. David Jones made a motion to close the public hearing. Wayne Tucker seconded the motion. All voted aye.

Mayor William Isley called the regular meeting to order and gave the invocation. David Jones led the Pledge of Allegiance.

**Amendments to Agenda**

Herbert Toles made a motion to amend the agenda to consider Resolution 2014-17 to amend the architectural contract for the safe rooms grant. David Jones seconded the motion. All voted aye.

David Jones made a motion to amend the agenda to consider Resolution 2014-18 concerning a curfew for homecoming week. Chip Martin seconded the motion. All voted aye.

Wayne Tucker made a motion to amend the agenda to consider a rental agreement for the downtown market. Herbert Toles seconded the motion. All voted aye.

David Jones made a motion to amend the agenda to hear information from Tammy Montgomery regarding a breast cancer research event. Wayne Tucker seconded the motion. All voted aye.

**Minutes of September 15 Regular Meeting**

Larry Jones made a motion to approve the minutes of the September 15, 2014 regular meeting. Wayne Tucker seconded the motion. All voted aye.

**Ordinance 2014-17 Rezone Jones Property**

David Jones made a motion to suspend the rules for immediate consideration of Ordinance 2014-17. Herbert Toles seconded the motion. A roll call vote was taken with results as follows: L. Jones – aye, D. Jones-aye, Martin-aye, Isley-aye, Tucker-aye, Marlin-aye, Toles-aye. Motion carried.

Herbert Toles made a motion to adopt Ordinance 2014-17 to zone the property owned by Walter and Sharon Jones located on Highway 11 to A-1 Agricultural Home District as recommended by the Planning and Zoning Commission. Wayne Tucker seconded the motion. All voted aye.

**Olivia Hutto – Turn Springville Pink**

Olivia Hutto presented information on Turn Springville Pink Day to be held on October 22 and events to be held on that date to raise funds for breast cancer research at UAB.

**FY 2015 Budget**

Chip Martin answered questions from the council regarding the proposed FY 2015 budget. After discussion, Chip Martin made a motion to approve the FY 2015 budget as presented. Hugh Marlin seconded the motion. All voted aye.

**Resolution 2014-17 Amend Architectural Contract for Safe Rooms Grant**

David Jones made a motion to approve Resolution 2014-17 to amend the architectural contract for the safe rooms grant to include third party peer review of the plans. Herbert Toles seconded the motion. All voted aye.

**Resolution 2014-18 Homecoming Week Curfew**

James Hill presented Resolution 2014-18 as requested by the Board of Education, to impose a curfew for minors during the week of homecoming activities to require any minor loitering in a public place after 10:00 p.m. be accompanied by a parent or guardian due to incidents of vandalism and criminal mischief. Wayne Tucker made a motion to approve Resolution 2014-18. Herbert Toles seconded the motion. After discussion, Wayne Tucker amended his motion to have the resolution include a more detailed definition of loitering. Herbert Toles seconded the motion. All voted aye.

**Rental Agreement for Events at Downtown Market**

David Jones made a motion to approve a rental agreement for events to be held at the downtown market. Chip Martin seconded the motion. All voted aye.

**Tammy Montgomery – Breast Cancer Research Walk**

Tammy Montgomery was not present.

**Mayor’s Report**

Department heads presented reports.

Mayor William Isley said that the county would do additional work on Purple Heart Blvd. outside the scope of the original agreement to slope back the curve to improve visibility. The additional work will cost \$8,000.00, half of which will be paid by the county.

Mayor William Isley discussed the lighting of the soccer field, meetings with the CDA regarding city-owned properties, the 5K Run and arts, crafts, and music festival to be held on October 18, and new businesses proposed for Springville.

With no further business to come before the council, Hugh Marlin made a motion to adjourn. Wayne Tucker seconded the motion. All voted aye.
