Mayor William Isley called the regular meeting to order and gave the invocation. David Jones led the Pledge of Allegiance.

Minutes of October 6 Regular Meeting

David Jones made a motion to approve the minutes of the October 6, 2014 regular meeting. Herbert Toles seconded the motion. All voted aye.

September 2014 Budget Report

Chip Martin made a motion to approve the September 2014 budget report. Wayne Tucker seconded the motion. All voted aye.

Rebecca Sanders – Parade Application

Rebecca Sanders was not present. Herbert Toles said that the parade was planned for November 29 on the day of the Alabama v Auburn football game in the Mountain Drive/Woody Street area. Request for Extension on Time to Abate Dangerous Structure Nuisance

Chip Martin made a motion to grant a 90 day extension for abatement of the structure nuisance located at 87 Crest Circle contingent on the property remaining vacant and marked with caution tape during that time. Wayne Tucker seconded the motion. All voted aye.

Resolution 2014-20 Declare Nuisance at 191 Sunset Drive

Jennifer Disker said that the property located at 191 Sunset Drive had been attended to and no further action was needed.

Resolution 2014-19 Declaration of Weed Nuisance in Macdonald Farms Lots 20/22/47/48/Entrance and Resolution 2014-20 Declaration of Debris Nuisance in MacDonald Farms Entrance Lot

After review of report prepared by the building inspector, Herbert Toles made a motion to adopt Resolution 2014-19 to declare a Lots 20, 22, 47, 48 and the entrance to Macdonald Farms to be a weed nuisance and to adopt Resolution 2014-20 to declare the entrance lot of MacDonald Farms to be a debris nuisance. Hugh Marlin seconded the motion. All voted aye.

Mayor's Report

Jennifer Disker said that the haunted house at the old rock school has been inspected prior to opening.

Mayor William Isley discussed the memorial service for Ron Black, a department heads meeting, progress at the sports park, and the Mayors Association meeting in Riverside on Tuesday.
