**Amendments to Agenda**

Katrina Hennings made a motion to amend the agenda to hear a report on the APS audit. Herbert Toles seconded the motion. All voted aye.

Herbert Toles made a motion to amend the agenda to discuss purchase of equipment. Katrina Hennings seconded the motion. All voted aye.

Hugh Marlin made a motion to amend the agenda to discuss providing gifts for a child for Christmas. Wayne Tucker seconded the motion. All voted aye.

**Resolution 2014-25 Request Legislative Annexation of Wolfe Property**

Larry Jones made a motion to adopt Resolution 2014-25 to request legislative annexation of noncontiguous property located in Heritage Valley Estates owned by James and Ramona Wolfe. Katrina Hennings seconded the motion. All voted aye.

**Request for Sanitary Facilities in Accessory Structure**

Pursuant to the zoning ordinance, Barlin Eugene Webb Jr. requested council permission to install sanitary facilities in an accessory structure that he will construct on property located at 7807 US Highway 11. Herbert Toles made a motion to grant permission for the sanitary facilities. Wayne Tucker seconded the motion. All voted aye.

**Engineering Contract for Streetscape Phase 3**

Hugh Marlin made a motion to authorize the mayor to enter into a contract with CCI Planning and Engineering for design engineering for Streetscape Phase 3. Katrina Hennings seconded the motion. All voted aye.

**November 2014 Budget Report**

**2014 Financial Audit**

**Reschedule January 19 Council Meeting**

**Resolution 2014-26 ALDOT Streetscape Agreement**

Herbert Toles made a motion to adopt Resolution 2014-26 to authorize the mayor to enter into an agreement with ALDOT for Streetscape Phase 3. Wayne Tucker seconded the motion. All voted aye.

**APS Audit**

Chip Martin said that an outside firm was hired to conduct an audit of collections of fines and court costs by Alabama Probation Service and that no discrepancies to the collection contract were found.

**Purchase of New Bobcat Compact Track Loader**

Chip Martin moved to purchase a new Bobcat Compact Track Loader through NJPA at a cost of \$50,472.43 subject to review by the city attorney. Wayne Tucker seconded the motion. All voted aye.

Wayne Tucker made a motion to adopt Resolution 2014-28 to surplus the currently owned Bobcat Compact Track Loader and authorize sale to Bobcat Co. at the fair market value of \$10,000.00. Herbert Toles seconded the motion. All voted aye.

Katrina Hennings made a motion to adopt Resolution 2014-29 authorizing the mayor to enter into a financing agreement with Metro Bank for \$40,000.00 for three years for purchase of the new Bobcat Compact Track Loader. Wayne Tucker seconded the motion. All voted aye.

**Fertilizer Contract for Sports Park Fields**

Katrina Hennings made a motion to authorize the mayor to receive proposals for fertilization and maintenance of fields at the sports park. Herbert Toles seconded the motion. All voted aye.

**Mayor's Report**

Mayor William Isley discussed providing gift for a family for Christmas, the Civil Air Patrol awards dinner, construction progress at the new city hall and the Sports Park, purchase of equipment for the library, and the Christmas Parade.
