Mayor William Isley called the regular meeting to order and gave the invocation. David Jones led the Pledge of Allegiance.

**Amendments to Agenda**

Herbert Toles made a motion to amend the agenda to consider Resolution 2015-15 regarding nuisance abatement. Wayne Tucker seconded the motion. All voted aye.

**Minutes of June 1 Regular Meeting**

David Jones made a motion to approve the minutes of the June 1 regular meeting. Herbert Toles seconded the motion. All voted aye.

**Installation of Sprinkler System**

Chip Martin made a motion to purchase and install a sprinkler system at the sports park at a cost of \$21,600.00 to Raindrops, who was the low bidder, to be paid from the Playground Equipment Fund. Herbert Toles seconded the motion. All voted aye.

**Signage for Property for Sale**

Larry Jones made a motion to authorize expenditure of up to \$3,000.00 to Masters Signs for signage to advertise City owned properties for sale at the sports park area and south of town on I59. Katrina Hennings seconded the motion. All voted aye.

**Civic Organization Signs**

Larry Jones made a motion to purchase a sign to display the logos of civic organizations from Masters Signs at a cost of \$650.00 and to install the sign on city property near the railroad crossing. Katrina Hennings seconded the motion. All voted aye.

**Katrina Hennings – Streets in District 4**

Discussion concerned the need for paving on streets in all districts. After discussion, it was decided that Mayor William Isley would ask the county commission to do additional paving while they are in town paving the Mountain View Drive and Purple Heart Blvd projects. Mayor William Isley asked each council member to consult with Wayne Tucker regarding the streets in need of paving and the appropriate type of material.

**Resolution 2015-15**

David Jones made a motion to approve Resolution 2015-15 to declare a public nuisance on Lots 1, 5, 6, 21, 22, 23, 24, 25, 30, 31, 32, 35, 36, 37, 38, 39, 40, 46, and 48 of Crandall Crest Subdivision and to require the property owner to abate the nuisance. Larry Jones seconded the motion. All voted aye.

**Chip Martin-Installation of Sod at Sports Park**

Chip Martin said that after the sprinkler system is installed, there will need to be installation of sod and aesthetics in some areas of the sports park. Larry Jones made a motion to authorize expenditure of up to \$7,500.00 from the playground equipment fund for this installation. Katrina Hennings seconded the motion. All voted aye.

**Mayor's Report**

Mayor William Isley said that an event would be held on June 24 at 6:30 p.m. at the high school softball field to recognize the state championship girls team. The event will be held in conjunction with the Argo city council as several of the player live in Argo.

Mayor William Isley discussed a stakeholders meeting for the Streetscape Phase 3 project and thanked Spring Valley Church for community service projects at Woody Street Park and the sports park.

Richard Harvey discussed plans to have a city flag designed to display at events.

Approval of the contract for construction of the storm shelters and the need for a construction road at the sports park were discussed. These issues will be addressed at the next meeting.

With no further business to come before the council, David Jones made a motion to adjourn. Katrina Hennings seconded the motion. All voted aye.
