Mayor William Isley called the regular meeting to order and gave the invocation. David Jones led the Pledge of Allegiance.

**Amendment to Agenda**

Herbert Toles made a motion to amend the agenda to include consideration of a parade permit submitted by Rebecca Sanders. Wayne Tucker seconded the motion. All voted aye.

**Parade Permit**

David Jones made a motion to approve a parade permit submitted by Rebecca Sanders for a parade on Mountain Drive at a time to be determined between November 26-28. Wayne Tucker seconded the motion. All voted aye.

**Minutes of November 2 Regular Meeting**

David Jones made a motion to approve the minutes of the November 2 regular meeting. Herbert Toles seconded the motion. All voted aye.

**Ordinance 2015-11 Amend Personnel Policy regarding Vacation Accrual**

David Jones made a motion to suspend the rules for immediate consideration of Ordinance 2015-11. Herbert Toles seconded the motion. A roll call vote was taken with results as follows: Toles-aye, Marlin-aye, Tucker-aye, Isley-aye, Martin-aye, DJones-aye, LJones-aye. Motion carried

Chip Martin made a motion to amend Ordinance 2007-11 (the Personnel Policy) to correct the accrual of vacation leave during the probationary period. Herbert Toles seconded the motion. All voted aye.

**Construction of Police Firing Range**

David Jones made a motion to amend the agenda to consider appropriation of funds to construct a firing range for the police department behind the existing police building. Wayne Tucker seconded the motion. All voted aye.

David Jones made a motion to approve expenditure of \$3,000.00 for construction of a firing range. Wayne Tucker seconded the motion. Wayne Tucker and Herbert Toles voted aye. Hugh Marlin, Mayor William Isley, Chip Martin, David Jones, and Larry Jones voted no. Motion failed.

Larry Jones made a motion to approve expenditure of up to \$5,000.00 for construction of a firing range. David Jones seconded the motion. All voted aye.

**Mayor's Report**

Mayor William Isley discussed assistance for a local family during Christmas, advertisement for a position in the building and zoning department, progress on the Forever Wild project, the installation of street lights on Purple Heart Blvd., and the Christmas Parade to be held on December 12.
