**Resolution 2016-05 Weed Nuisance Abatement – Macdonald Farm**

Herbert Toles made a motion to approve Resolution 2016-05 declaring a public nuisance due to weeds on Lots 20, 22, 47, 48 and the entrance in Macdonald Farm. Hugh Marlin seconded the motion. All voted aye.

**Ordinance 2016-04 Back to School Sales Tax Holiday**

David Jones made a motion to suspend the rules for immediate consideration of Ordinance 2016-04. Katrina Hennings seconded the motion. A roll call vote was taken with results as follows: Toles-aye, Marlin-aye, Tucker-aye, Isley-aye, Hennings-aye, Martin-aye, DJones-aye, LJones-aye. Motion carried.

Herbert Toles made a motion to adopt Ordinance 2016-04 to declare a sales tax holiday on certain covered items during the first weekend of August as authorized by Act 2006-574. Wayne Tucker seconded the motion. All voted aye.

**Deborah Owen – Springville Band Boosters**

Deborah Owen, secretary of the Springville Band Boosters, requested a contribution toward purchase of meals for band members during band camp. Wayne Tucker made a motion to contribute \$800.00 to Springville High School for the purchase of meals for the band camp. Hugh Marlin seconded the motion. All voted aye.

After discussion, Wayne Tucker made a motion to suspend the rules for immediate consideration of Resolution 2016-04. Katrina Hennings seconded the motion. A roll call vote was taken with results as follows: Toles-aye, Marlin-aye, Tucker-aye, Isley-aye, Hennings-aye, Martin-aye, DJones-aye, LJones-aye. Motion carried.

Hugh Marlin made a motion to approve Resolution 2016-04 to remove the Springville Public Library from the St. Clair County Library Board. Wayne Tucker seconded the motion. All voted aye.
