Mayor Pro Tempore Wayne Tucker called the regular meeting to order. David Jones gave the invocation. Larry Jones led the Pledge of Allegiance.

Public Hearing – Macdonald Farms Weed Abatement

Ron Sharit presented a report to the council concerning the previous declaration of a weed nuisance on lots in Macdonald Farms. All of the lots except one have been cleaned. Mr. Sharit recommended that the council proceed with the nuisance abatement process on Lot 20.

Mayor Pro Tempore Wayne Tucker asked for public comment. No comments were heard.

David Jones made a motion to close the public hearing. Larry Jones seconded the motion. All voted aye.

Amendments to Agenda

David Jones made a motion to amend the agenda to consider discussion of mosquito control to be provided by First Baptist Church Springville and to remove Pedro Pino from the agenda at his request. Herbert Toles seconded the motion. All voted aye.

Minutes of May 19 Regular Meeting

Herbert Toles made a motion to approve the minutes of the May 19, 2016 regular meeting. Hugh Marlin seconded the motion. All voted aye.

April 2016 Budget Report

Chip Martin made a motion to approve the April 2016 budget report. David Jones seconded the motion. All voted aye.

Mosquito Control for First Baptist Church Vacation Bible School

David Jones made a motion to authorize the mayor to sign an agreement with First Baptist Church of Springville to provide mosquito control service at no cost to the city at Big Springs Park during the week of their vacation bible school which will be held at the park. Herbert Toles seconded the motion. All voted aye.

City Mosquito Control

Chip Martin made a motion to table the discussion regarding contracting out the city's mosquito control service to a licensed contractor until the next meeting. Hugh Marlin seconded the motion. All voted aye.

Resolution 2016-07 Weed Nuisance Abatement – Macdonald Farm

Herbert Toles made a motion to approve Resolution 2016-07 ordering the abatement of a public nuisance due to weeds on Lot 20 in Macdonald Farm and awarding the contract to the lowest bidder. Chip Martin seconded the motion. All voted aye.

Ordinance 2016-05 Surplus of VFW Building for Rentals

David Jones made a motion to suspend the rules for immediate consideration of Ordinance 2016-05. Hugh Marlin seconded the motion. A roll call vote was taken with results as follows: Toles-aye, Marlin-aye, Tucker-aye, Martin-aye, DJones-aye, LJones-aye. Motion carried.

Chip Martin made a motion to approve Ordinance 2016-05 to declare the VFW building to be surplus property that may be leased as needed. Hugh Marlin seconded the motion. All voted aye.

Lease Agreement with Alethia House for VFW Lease

Larry Jones made a motion to authorize Mayor William Isley to enter into an agreement with Alethia House to provide a free comprehensive substance abuse and violence prevention program to children aged 6-13 from June 20 – July 15 that includes lease of the VFW building during that time for \$500.00. Hugh Marlin seconded the motion. All voted aye.
