Mayor William Isley called the regular meeting to order and Mike Ennis from Faith Community Fellowship gave the invocation. David Jones led the Pledge of Allegiance.

**Tim Walker-Oath of Office**

Honorable Jim Hill administered the Oath of Office to Tim Walker, Council Member for District 5.

**Minutes of July 17 Regular Meeting**

David Jones made a motion to approve the minutes of the July 17 regular meeting. Sherry Reaves seconded the motion. All voted aye.

**June 2017 Budget Report**

Sherry Reaves made a motion to approve the June 2017 budget report. Katrina Hennings seconded the motion. All voted aye.

**Animal Control Contract with Pell City**

Herbert Toles made a motion to authorize the mayor to enter into a contract for animal control services with the City of Pell City for the 2017-18 fiscal year at a cost of \$9,500.00. Wayne Tucker seconded the motion. All voted aye.

**Resolution 2017-07 Accepting Streets in Middle Ridge**

Earl Peoples said that he has received the required request from the residents in Middle Ridge to accept the streets in the subdivision and assume the maintenance on the streets. Earl said that he has inspected the streets and recommends acceptance of the streets with an additional two-year warranty provided by Southern Sealcoating Inc. due to cosmetic issues on two cul-de-sacs. Sherry Reaves made a motion to adopt Resolution 2017-07 accepting the streets in Middle Ridge. Wayne Tucker seconded the motion. All voted aye.

**Board Appointment**

David Jones made a motion to reappoint Joe Cox to the Board of Adjustment for a three-year term. Herbert Toles seconded the motion. All voted aye.

**Board Appointment**

Hugh Marlin made a motion to appoint Allen Crawford to the Planning & Zoning Commission to fill the unexpired term of Chester Harris who has resigned. Katrina Hennings seconded the motion. All voted aye.

**St. Clair Times Football Ad**

Hugh Marlin made a motion to purchase an advertisement in the St. Clair Times Football Edition at a cost of \$390.20. Wayne Tucker seconded the motion. All voted aye.

**Reschedule August 21 Regular Council Meeting**

Herbert Toles made a motion to reschedule the August 21 regular council meeting to August 28 due to the city clerk and mayor being out of town. Wayne Tucker seconded the motion. All voted aye.

**Reschedule September 4 Regular Council Meeting**

David Jones made a motion to reschedule the September 4 regular council meeting to September 12 due to the Labor Day holiday. Sherry Reaves seconded the motion. All voted aye.

**Kathy Burttram- Springville Preservation Society Request**

Mayor William Isley presented a request from the Springville Preservation Society for the city to provide internet and wifi for their building on Main Street. Mayor Isley said that he had received preliminary information from the city attorney that there could be legal issues with providing the service and that he would like to further research the matter. Mayor Isley made a motion to table the discussion to a future date. Katrina Hennings seconded the motion. All voted aye.

**Mountain View Lane Paving**

Katrina Hennings made a motion to authorize the mayor to enter into a contract for paving repair on Mountain View Lane with Massey Asphalt Paving at a cost of \$14,825.00. Hugh Marlin seconded the motion. All voted aye.

**Katrina Hennings – Fern Creek Roads, Speeding, Animal Control**

Katrina Hennings said that she has received complaints from residents in Fern Creek regarding road conditions, speeding, and unleashed dogs. The council discussed the issue that the roads in Fern Creek have not been completed by the developer and accepted by the city. Mayor William Isley asked Katrina Hennings to have residents call animal control to try to catch the dogs when they are in the area. Katrina Hennings made a motion to install “speed limit strictly enforced” signage in the area. Herbert Toles seconded the motion. All voted aye.

**Herbert Toles – Ditch in District 1**

Herbert Toles discussed concerns regarding two ditches in District 1 that were discussed at the previous meeting. Wayne Tucker described the necessary repairs and Mayor William Isley asked Earl Peoples to have the repairs to the ditches made by installing rip rap ditch checks at necessary intervals. Mayor William Isley asked Earl to have the work completed by September 30.

**Mayor’s Report**

Department heads gave reports.

Jamie Twente introduced library staff, Vickie Stone, Linda Williams, Ann Sargent, and Sarah Reese and discussed the programs the library is offering for children and adults.

Mayor William Isley introduced Building Inspector Asa Sargent, thanked Sherry Reaves for her work on Movies in the Park, congratulated Katrina Hennings on completion of the Alabama League of Municipalities Certified Municipal Official program, and discussed the Farmers Market and a prayer group at 180 Church.

With no further business to come before the council, Herbert Toles made a motion to adjourn. Katrina Hennings seconded the motion. All voted aye.
