Mayor William Isley called the regular meeting to order and Mike Ennis from Faith Community Fellowship gave the invocation. David Jones led the Pledge of Allegiance.

Amendments to Agenda

Wayne Tucker made a motion to amend the agenda to consider Ordinance 2017-06 regarding leasing of the senior center. Katrina Hennings seconded the motion. All voted aye except David Jones who abstained. Motion carried.

David Jones made a motion to amend the agenda to discuss weed abatement in District 2. Herbert Toles seconded the motion. All voted aye.

Hugh Marlin made a motion to amend the agenda to discuss installation of a cross walk on Highway 11 at the Methodist Church due to the relocation of the polling site for elections. Wayne Tucker seconded the motion. All voted aye.

Carrie Denton – Senior Center

Carrie Denton presented information regarding activities and flooding issues at the senior center.

Minutes of August 7 Regular Meeting

Herbert Toles made a motion to approve the minutes of the August 7 regular meeting. Sherry Reaves seconded the motion. All voted aye.

Board Appointment

Hugh Marlin made a motion to reappoint Allen Crawford to a 3 year term on the Board of Adjustment. Katrina Hennings seconded the motion. All voted aye.

Mayoral Board Appointment

Mayor William Isley appointed Walter Coleman, Jr. to the Planning and Zoning Commission for a 6 year term.

Ordinance 2017-06 Senior Center Lease

Wayne Tucker made a motion to suspend the rules for immediate consideration of Ordinance 2017-06. Katrina Hennings seconded the motion. A roll call vote was taken with results as follows: Toles-aye, Marlin-aye, Tucker-aye, Isley-aye, Hennings-aye, Walker-aye, Jones-aye, Reaves-aye. Motion carried.

Wayne Tucker made a motion to adopt Ordinance 2017-06 authorizing the lease of the senior center to Life Spring Church on each Sunday for a period of 12 months from 9:00am – 12:00p.m. for a cost of \$250 / month – said amount considered as adequate. Sherry Reaves seconded the motion. All voted aye except David Jones who abstained. Motion carried.

Hugh Marlin-Weed Abatement in Macdonald Farms

Hugh Marlin asked Earl Peoples to check on weed complaints in Macdonald Farms subdivision and begin the abatement process if necessary.

Crosswalk on US 11

David Jones made a motion to authorize Mayor William Isley to determine costs and ALDOT requirements to install a crosswalk and lighting, etc. on US Highway 11 in front of the Methodist Church due to the church being the polling place for upcoming elections. Katrina Hennings seconded the motion. All voted aye.

Playground Equipment – Woody Park

Mayor William Isley said that he would have information at the next meeting on the purchase and installation of playground equipment at Woody Park.

Mayor’s Report

Mayor William Isley discussed recent work days for 180 Church and Faith Community Fellowship, closing on the property sale for the pediatric clinic, and recent training he had attended.
