Mayor William Isley called the meeting to order and gave the invocation. David Jones led the Pledge of Allegiance.

**Presentation to 180 Church**

Theresa Burton presented a plaque to Pastor Gresh Harbuck of 180 Church in appreciation for their contribution of \$4,006.02 to the Senior Citizens Program. This contribution was used to purchase a kiln to be used in a ceramics program at the senior center.

**Minutes of February 4, 2013 Regular Meeting**

David Jones made a motion to approve the minutes of the January 22, 2013 regular council meeting. Herbert Toles seconded the motion. All voted aye.

**January 2013 Budget Report**

Katrina Hennings made a motion to approve the January 2013 budget report. Wayne Tucker seconded the motion. All voted aye.

**2013 St. Clair County Water Festival Sponsorship**

Herbert Toles made a motion to sponsor the St. Clair County Water Festival at a cost of \$250.00. Hugh Marlin seconded the motion. All voted aye.

**Ordinance 2013-02 Springville Cemetery Association**

James Hill introduced Ordinance 2013-02 to clarify the contract between the city and the Springville Cemetery Association.

David Jones made a motion to suspend the rules for immediate consideration of Ordinance 2013-02. Herbert Toles seconded the motion. A roll call vote was taken with results as follows: L. Jones-aye, D. Jones-aye, Hennings-aye, Isley-aye, Tucker-aye, Marlin-aye, Toles-aye. Motion carried.

David Jones made a motion to adopt Ordinance 2013-02. Katrina Hennings seconded the motion. All voted aye.

**Ordinance 2013-03 Annexation of Sports Park Property**

Mayor William Isley introduced Ordinance 2013-03 to annex by petition the sports park property located on Springville Station Blvd.

Herbert Toles made a motion to suspend the rules for immediate consideration of Ordinance 2013-31. Hugh Marlin seconded the motion. A roll call vote was taken with results as follows: L. Jones-aye, D. Jones-aye, Hennings-aye, Isley-aye, Tucker-aye, Marlin-aye, Toles-aye. Motion carried.

Katrina Hennings made a motion to adopt Ordinance 2013-03. Wayne Tucker seconded the motion. All voted aye.

**Resolution 2013-11 and Resolution 2013-12 Cost Confirmation for Nuisance Abatements**

James Hill introduced Resolution 2013-11 and Resolution 2013-12 to itemize the costs of abatement of weed nuisances at Lot 20 of Macdonald Farm and at 276 Robinson Street. Liens may be placed on the properties to collect the costs of abatement of weed nuisances at the locations.

Herbert Toles made a motion to approve Resolution 2013-11 and 2013-12. Larry Jones seconded the motion. All voted aye.

**Resolution 2013-10 MOU with EMA for Local Distribution/Staging Site**

Wayne Tucker made a motion to approve Resolution 2013-10 to authorize Mayor William Isley to sign a memorandum of understanding with the EMA to use the VFW building as a distribution and staging site for disaster relief. Hugh Marlin seconded the motion. All voted aye.

**Mayor's Report**

Mayor William Isley asked Candace Hill from the Economic Development Council to address the council regarding development in the county. Ms. Hill said that they have begun to see an increase in development county-wide and hoped to work with the CDA to promote development in Springville.

Mayor William Isley said that the soccer season would begin in March on the new fields at the Sports Park and that work was continuing on tennis facilities for the park.

Mayor William Isley discussed ongoing projects including the police building, Streetscape, landscaping at the walking track, Clean Up Day, and Fishing Day.

**Laura Cheney-Springville Library Foundation**

Laura Cheney presented a video promoting the construction of a new library and asked the council to commit to a partnership for funding of the new construction.

**John Russell-Municipal Court**

John Russell addressed the council regarding concerns related to municipal court and Judge Larry Ward. City Attorney James Hill responded to the Council related oversight of the Municipal Court in Springville.

With no further business to come before the council, Wayne Tucker made a motion to adjourn. Herbert Toles seconded the motion. All voted aye.
