### **Public Hearing – CDBG Application**

Louise Campbell presented information concerning CDBG applications for FY 2013 and asked for public comments regarding the proposed application. No comments were heard. Ms. Campbell recommended that the city apply for grant funding for paving and drainage improvement in the area of Mountain Drive. After discussion, Ms. Campbell said that she would begin the data gathering work to start the application process.

Mayor William Isley closed the public hearing.

Mayor William Isley called the regular meeting to order and gave the invocation. David Jones led the Pledge of Allegiance.

#### **Amendments to Agenda**

David Jones made a motion to amend the agenda to consider a resolution requesting the legislature pass an act authorizing the Springville Municipal Court to assess a warrant recall fee against defendants in municipal court. Katrina Hennings seconded the motion. All voted aye.

## Minutes of March 18, 2013 Work Session and Regular Meeting

David Jones made a motion to approve the minutes of the March 18, 2013 work session and regular meeting. Herbert Toles seconded the motion. All voted aye.

#### Ordinance 2013-08 Back to School Sales Tax Holiday

David Jones made a motion to suspend the rules for immediate consideration of Ordinance 2013-08. Wayne Tucker seconded the motion. A roll call vote was taken with results as follows: L. Jones – aye, D. Jones-aye, Martin-aye, Hennings-aye, Isley-aye, Tucker-aye, Marlin-aye, Toles-aye. Motion carried.

Herbert Toles made a motion to approve Ordinance 2013-08 to exempt certain items from the municipal sales and use tax during the first full weekend of August, 2013, as authorized by Act 2006-574. Hugh Marlin seconded the motion. All voted aye.

# Herbert Toles-Purple Heart Blvd., Debris Collection, Clean Up Day

Herbert Toles discussed the pending road improvement work to be done on Purple Heart Blvd and the change in the scope of the work.

Herbert Toles asked about the debris pick up issues with the current provider. Earl Peoples said that the coming week was the week scheduled for pick up and asked that the council reevaluate the service after this week.

Herbert Toles asked about using student volunteers for Clean Up Day and expressed concerns about safety for workers for that event. Mayor William Isley asked that all volunteers be assigned to low traffic areas for pick up. The council also said that the quoted price for shredding service was too high and would not be included in the Clean Up Day activities.

## Resolution 2013-14 Request for Legislative Action Authorizing Warrant Recall Fee

City Attorney James Hill presented Resolution 2013-14 requesting that the legislature authorize the Springville Municipal Court to charge a warrant recall fee of \$100.00 to recall any Failure to Appear or capias warrant issued thereby.

David Jones made a motion to approve Resolution 2013-14. Chip Martin seconded the motion. All voted aye.

### Mayor's Report

Mayor William Isley asked that council members review the list of street paving that has been sent to the county to be sure that priority projects appear on that list.

Mayor William Isley said that the Dangerous Animal Ordinance would be presented at the next meeting. Larry Jones gave some information on the proposed ordinance and the council discussed the manner of enforcement through animal control rather than through law enforcement.

Mayor William Isley discussed upcoming events, the Farmer's Market project, and the community safe rooms grant.

With no further business to come before the council, Katrina Hennings made a motion to adjourn. Herbert Toles seconded the motion. All voted aye.
