<u>David Hudson – MacDonald Farms</u>

David Hudson represented residents of MacDonald Farms and discussed issues with the security lights and retention pond at the church property adjacent to the subdivision. Mr. Hudson said that the problems have been brought to the attention of the church but no action has been taken to correct them. Earl Peoples said that he had observed the problems and contacted the church. After discussion, Mayor William Isley asked Earl Peoples to report on the progress at the next meeting and asked Mr. Hudson to keep him informed of the conditions on the property.

Speed Limit Changes on County Roads

Chief Greg Charles reported that he had spoken with Charles Malone from ALDOT about the speed limit on Highway 174 at the I59 overpass and Mr. Malone said that he would schedule a traffic study for the area. After discussion, Wayne Tucker made a motion to authorize Earl Peoples to contact the county regarding changing the speed limit on Highway 174 to 45 m.p.h from the northern city limits to Canoe Creek Road. Herbert Toles seconded the motion. All voted aye.

Beautification Issues

After a discussion of the need for flowers in planters located along Highway 11, David Jones made a motion to revise the agenda to allow consideration of an allocation of funds for the purchase of flowers. John Coyne seconded the motion. All voted aye.

David Jones made a motion to authorize Earl Peoples to spend up to \$300.00 to purchase and plant flowers in the City's planters on Highway 11. John Coyne seconded the motion. All voted aye.

Mayor's Report

Mayor William Isley reported on the plans for SpringFest, Take A Kid Fishing Day, and the Arts Council Yard Sale.

Mayor William Isley gave progress reports on projects including the Sports Park, Splashpad, police building, and the senior center.
