The City Council of the City of Springville (the "Council") held its regularly scheduled meeting at 6:00 P.M. on June 21, 2010.

Mayor Pro Tempore Wayne Tucker called the regular council meeting to order. David Jones gave the invocation and John Coyne led the Pledge of Allegiance.

**Visitors**

June Mack with the Springville Community Theatre was recognized and requested a contribution toward the Theatre's presentation of "Oklahoma" to be performed at Homestead Hollow in July and August.

**Notification to owners of nuisance buildings**

Reports on three nuisance buildings were presented that had been prepared by Building Official Richard Harvey, who was not present. Earl Peoples said that he and Richard had been working on the existing files on nuisance buildings and were requesting direction from the council to proceed with the process to demolish the buildings. **Contribution to Springville Community Theatre**

Brian Skinner made a motion to make a contribution of \$1,000.00 to the Springville Community Theatre through the Chamber of Commerce. David Jones seconded the motion. All voted aye.

**Reschedule regular meeting of July 5**

Herbert Toles made a motion to reschedule the regular meeting of the city council from July 5 to July 8 due to the holiday. Katrina Hennings seconded the motion. All voted aye.

**John Coyne – Increase take-home vehicle distance for emergency personnel**

John Coyne said that he would like the council to consider increasing the allowable distance for take-home vehicles for emergency personnel to twenty miles. This would allow all except one police officer to drive a vehicle home which would decrease response time in emergencies. The council discussed the take home vehicle policy and other requests made by Chief Charles at the previous meeting. Chief Charles said that he had not had an opportunity to discuss the issues with Mayor Isley since the last meeting. James Hill said that he had researched the question of reduced supervision with the attorney general's office and with AMIC and recommended that the council consider Chief Charles' request to promote some patrol officers to sergeant even if there is no pay increase due to budget constraints. After discussion, David Jones made a motion to table the discussion until the next regular meeting so that the

mayor can participate in the discussion and so that Chief Charles can discuss his requests with the mayor. John Coyne seconded the motion. All voted aye.

**Approval of minutes of June 7, 2010 regular meeting**

David Jones made a motion to approve the minutes of the regular meeting held on June 7, 2010. Katrina Hennings seconded the motion. All voted aye.

**Approval of financial report for May 2010**

Hugh Marlin made a motion to approve the financial report for May 2010. David Jones seconded the motion. All voted aye.

With no further business to come before the council, Herbert Toles made a motion to adjourn at 6:30 PM. David Jones seconded the motion. Motion carried unanimously.
