**Visitor: Bradley Reed**

Bradley Reed from Robinson Lane was recognized and discussed speeding and reckless driving on Robinson Street. After discussion, Mayor Isley asked Chief Charles to provide extra police patrol in the area and asked Mr. Reed to report any specific vehicles to the police department. Mayor Isley asked Earl Peoples to get a cost estimate on replacing the bridges with pipe and widening the road. Mayor Isley also asked Earl Peoples to remove any stop signs that are located at railroad crossings with gates and flashing lights.

**Resolution 2010-24 Requesting AG Opinion Regarding Developers**

James Hill introduced resolution 2010-24 to request an attorney general's opinion regarding developers who do fail to build improvements to the specifications of the subdivision regulations. This is a result of complaints from residents in several subdivisions in which developers have failed to complete the subdivision improvements to the specifications of the subdivision regulations, including paving and maintaining the roads, and have allowed their financial insurance to lapse. The AG opinion will determine what recourse, if any, the city has against the developers.

**Resolution 2010-25 Accepting the Crown Binder Buildings as a Gift**

James Hill introduced Resolution 2010-25 to accept the Crown Binder Buildings as a gift to the city, have an appraisal done, and provide a gift letter to the owners.

**Herbert Toles – Paving on Mountain Drive**

Herbert Toles asked Mayor Isley if he had received the cost estimate from the county for paving on Mountain Drive. Mayor William Isley said that the invoice had been received but he had not reviewed it. Herbert Toles said that the city’s cost is approximately \$3,000.00. Mayor William Isley said that he budget committee will need to consider the inclusion of funding for paving in the FY11 budget.

**Big Springs Park**

Mayor William Isley said that the new playground equipment has been installed at the park and the fencing and concrete work should be complete this week.
