Mayor William Isley called the regular meeting to order and gave the invocation. John Coyne led the Pledge of Allegiance.

**Amend Agenda to Hear Request from Miss St. Clair Area Pageant**

David Jones made a motion to amend the agenda to allow discussion on a request from Karen Brantley with the Miss St. Clair Area Pageant for funding for the pageant. Ms. Brantley explained that the pageant is a preliminary pageant to the Miss Alabama pageant and is a scholarship pageant. Michelle Stringer and Cassie Jackson spoke on their platforms and the benefits of the scholarship program. Ms. Brantley asked for a contribution to the pageant.

**Resolution 2010-31 Award Downtown Drainage Improvements Contract**

David Jones made a motion to adopt resolution 2010-31 awarding the construction contract for the Downtown Drainage Improvements Hazard Mitigation Program to Civil Contractors LLC in the amount of \$141,120.00 and authorize the mayor to sign all contract documents. Katrina Hennings seconded the motion. All voted aye.

**Agreement for Stipend for Temporary Building Inspector**

Wayne Tucker made a motion to enter into an agreement with Richard Harvey to perform the duties of Building Inspector until an Inspector is hired for compensation of \$5,000.00 per year. John Coyne seconded the motion. All voted aye.

**Approve Minutes of October 4th Regular Meeting**

Wayne Tucker made a motion to approve the minutes of the October 4, 2010 regular council meeting. Hugh Marlin seconded the motion. All voted aye.

**Approve Financial Report for August 2010**

David Jones made a motion to approve the financial report for August 2010. John Coyne seconded the motion. All voted aye.

**John Coyne - Veteran's Day Event**

John Coyne announced that work has begun on the Veteran's Day Event to be held on November 9 at 6:00pm and invited everyone to attend. The council noted that \$2,000.00 has been budgeted for the program.

**John Coyne – Hazardous Sign**

John Coyne reported that there is a sign at the intersection of Industrial Drive and Highway 11 that is obstructing the view of drivers entering Highway 11. James Hill said that he would send a letter to the owner requesting that the sign be moved to a location that will not obstruct the view.

**Herbert Toles – Paving Mountain Drive**

Herbert Toles made a motion to enter into an agreement with the St. Clair County Commission for improvements on Mountain Drive at a cost of \$2,582.50 to the city with the county paying the remained cost of \$1,162.50. Wayne Tucker advised that he was aware of and had personally viewed the roadway at issue and that the proposed were needed to protect the city maintained roadway from further deterioration and thus, greater expense to the City and greater hazard to the citizens. David Jones seconded the motion. All voted aye.

**Contribution to Miss St. Clair Area Pageant**

Brian Skinner made a motion to make a contribution through the Chamber of Commerce for the Miss St. Clair Area Pageant in the amount of \$250.00. Herbert Toles seconded the motion. All voted aye.

With no further business to come before the council, David Jones made a motion to adjourn. Herbert Toles seconded the motion. All voted aye. Meeting adjourned at 6:45PM.
