**Amendments to Agenda**

John Coyne made a motion to amend the agenda to allow a discussion of Refuge Ministries request for assistance in providing Christmas toys for families in Springville. Katrina Hennings seconded the motion. All voted aye.

Hugh Marlin made a motion to amend the agenda to allow discussion of the Christmas Parade float. John Coyne seconded the motion. All voted aye.

David Jones made a motion to amend the agenda to allow John Coyne to discuss the purchase of new Christmas lights. Katrina Hennings seconded the motion. All voted aye.

**Resolution 2011-24 Approving the Transfer of the Cable Franchise**

David Jones made a motion to approve Resolution 2011-24 approving the transfer of the cable franchise from Alabama Broadband LLC to Charter Communications LLC. Katrina Hennings seconded the motion. All voted aye.

John Coyne made a motion to purchase a horse and carriage lighted Christmas decoration at an approximate cost of \$850.00 if it can be delivered within the week. Katrina Hennings seconded the motion. All voted aye.

**Refuge Ministries**

Following a discussion of the request from Refuge Ministries for help in providing Christmas assistance to families in Springville, Council Members and employees agreed to individually provide the requested assistance.

**Earl Peoples-Coosa Valley Water Authority**

Earl Peoples said that the changeover to Coosa Valley Water had occurred on Tuesday, November 29. After discussion on providing water to the southern end of the city rather than purchase from Trussville Utilities, Mayor William Isley asked Earl to continue getting easements to run water lines to the area from Camp Road and to report the progress at a future meeting.
