**Judge Alan Furr – Juvenile Detention Facility**

Judge Alan Furr presented information regarding the short-term juvenile detention facility in Ashville and thanked the council for Springville's participation in funding the facility.

**Minutes of September 3, 2013 Regular Meeting and Work Session**

Herbert Toles made a motion to approve the minutes of the September 3, 2013 regular meeting and work session. David Jones seconded the motion. All voted aye.

**Springville Elementary School Technology Funding**

Mayor William Isley made a motion to contribute \$6000.00 through the Chamber of Commerce to Springville Elementary School for technology for the computer lab. Katrina Hennings seconded the motion. All voted aye.

**Parade Application**

David Jones made a motion to approve a parade permit application submitted by Springville High School for the Homecoming Parade on October 4. Herbert Toles seconded the motion. All voted aye.

**Hugh Marlin – MacDonald Farms Streets**

Hugh Marlin thanked the council for the information provided at the previous work session and asked James Hill to report further information regarding the streets in the subdivision. James Hill said that there are significant differences in the cases in other cities where lawsuits have been filed by the city against the developer of subdivisions. James Hill answered questions from homeowners regarding the options available. Mayor William Isley asked James Hill to continue his analysis of the situation and to report back to the council within 30 days.

**Mayor's Report**

Mayor William Isley said that he has met with representatives of Waste Management regarding the debris pickup and asked all residents with uncollected debris to report it to public works.
