Public Hearing-Zoning Ordinance Amendment

Mayor William Isley opened a public hearing regarding an amendment to the zoning ordinance adding pet grooming clinics and veterinarians as special exception uses in B-2 General Business Districts and I-1 Light Industrial Districts. Faye Kinstler asked about location of certain districts. City Attorney James Hill explained this amendment allows those uses in these two zones only by special exception permit from the Board of Adjustment. The public hearing was closed.

Honeywell Lease Agreement Debt Restructure

City Attorney, James Hill said that he has negotiated a buyout of the Honeywell lease agreement for water meters in the amount of \$1.35 million. This represents a reduction of approximately \$400,000 on the principal balance of these annual appropriations in aggregate and allows for issuance of water bonds that will not affect the city's general obligation debt limit.

David Jones made a motion to adopt Resolution 2013-33 authorizing the mayor to enter into an agreement with Honeywell and to pursue financing to restructure the Honeywell debt consistent with the City Attorney's recommendations. Wayne Tucker seconded the motion. All voted aye.

John Coyne-Veterans Day

John Coyne invited everyone to attend the Veterans Day event to be held on November 11 at 5:30 p.m. at the Methodist Church.

Mayor's Report

Mayor William Isley thanked Faye Kinstler for flowers planted in front of the annex building, and heard reports from department heads.
