Big Canoe Creek Nature Preserve Comprehensive Master Plan

Dean Goforth introduced Abraham Odrezin with LMO Partners who presented a proposal for development of a comprehensive master plan for the Big Canoe Creek Nature Preserve. David Jones made a motion to authorize Mayor William Isley to enter into a contract with LMO Partners for development of the master plan at a cost not to exceed \$12,000.00. US Highway11 and Highway 174 Infrastructure Improvements

Sherry Reaves made a motion to authorize Mayor William Isley to send a letter(s) to GBRPC seeking TIP funding for preliminary engineering for permanent improvements at the intersection of US 11 and Highway 174. David Jones seconded the motion. All voted aye.
